## TERMS OF AGREEMENT

1. I agree to be bound by the rules and regulations and by-laws of the Pied Piper Co-operative Preschool Incorporated ("Pied Piper")
2. I hereby give permission for a physician to give necessary treatment in case of an emergency situation where parents cannot be reached and a delay, in the opinion of medical staff, would be detrimental to the health of my child. It is understood that every effort will be made to contact the parents. This consent also gives the supervisor permission to administer the above listed medications in the event of an emergency.
3. I agree that tuition cheques for the entire year are to be submitted no later than the morning of the first day of school. They must be post-dated for the 1<sup>st</sup> of each month. NSF cheques will be subject to an additional \$40 charge.
4. I agree to pay the registration fee of \$125 to hold my child's spot, which is non-refundable should I withdraw my child from the preschool.
5. I agree to submit the required forms and health information no later than the morning of the first day of school.
6. I agree that any photos (still or video) that I take of the preschool children during class time or at special events will not be used on the internet. (ie. Facebook or Instagram etc.)
7. I acknowledge that membership in the co-op will terminate when fees are no longer paid.
8. I understand that two (2) commitment cheques, dated December 1<sup>st</sup> and May 1<sup>st</sup>, each for \$100, must be submitted no later than the morning of the first day of school. These cheques will not be cashed if all membership obligations are met.
9. I agree to have read and understood the Parent Handbook and preschools policies, and hereby agree to abide by the rules and regulations of the Executive Committee and the General Membership.
10. I agree to attend a minimum of three (3) general meetings. (Currently held over zoom). A \$45 fee will be charged each time a meeting is missed.
11. I agree to participate in one committee/co-operative job per year.
12. I agree to complete an additional two (2) clean up days per year. \$45 will be charged for each clean up day missed.
13. I agree to participate as an Environmental Cleaner or pay the required fee of \$30 in addition to monthly tuition fees.
  - a) It is the responsibility of the parent/caregiver to arrange another parent (and reciprocate later) to cover the scheduled cleaning day.
  - b) I understand that if I do not show up and unable to find coverage for my cleaning day, I will be charged a \$60 fee.
14. I understand that failure to comply with any of the above could result in the removal of my child at Pied Piper.
